I request that you include all of this in your article, and don't edit it to your liking, as my statements are completely factual and address each of the issues you have presented.

We have a top tier event as always taking place on Saturday March 8th in Chillicothe Ohio at the OU-C Shoemaker Center, with headliners, such as, Mick Foley, Hillbilly Jim, Kevin Von Erich, Honky Tonk Man, Billy Gunn and others. Tickets start at only \$20. Tickets are available at http://bpt.me/event/6500575!

RVD, Sabu and Matt Riddle were unprofessional. RVD is upset that we are no longer using him for events due to his refusal to renegotiate wages for future events. His value had dropped. Sabu was someone we attempted to help due to my father having a love for Sabu's Uncle The Original Sheik, we helped him out and bailed out of situations many times. I spoke to Sabu earlier today and he asked to be booked for future events, which at this point we will not work with him, due to the issues that he has ongoing. We wish Sabu the best in his future endeavors. Matt Riddle was unprofessional and tried to renegotiate the appearance fee the morning of the event, as we had a written agreement via text with the talent and he attempted a hold up the day of.

My father speaks with Billy Corgan almost daily, and we have came to the conclusion that he didn't attempt to have talent pulled. That's why we have removed the posts that we had up. I would say we are on good terms as we have Big Mama, who is a champion for their company on our March 8th event.

We typically never have contracts in wrestling, as the history of wrestling is based upon a person's word and at that point it has usually been suffice. Unfortunately, Matt Riddle showed his word is meaningless, including what he tells fans in promos for events, as he told the fans he would be in attendance and failed us along with the fans by not attending. He has issues and his issues caused him to no longer work with the WWE. As far as talent receiving payments, we have always paid the talents what we promised, that's why we have worked with hundreds of talents. Our company has existed since 1977, you don't last nearly 50 years without being of your word. Unfortunately this industry is very cutthroat, where people can be jealous of the success of others and attempt to tear them down. Also, any talent that has an issue with us, usually lies around the fact that we don't have them booked, usually these are talents that have history themselves of not being straightforward

and not doing business properly or professionally. As far as forged autographs go, we've always done signings via in-person meet and greets, where folks will meet the talent face to face and see the items being signed in front of them, which fans enjoy. We were doing virtual meet and greets during the pandemic, during which fans could see their items being signed via video as well as photograph. All items that we have resold will pass a third party authentication.

As far as booking talents, you either contact them directly or through an agent, and you agree to terms for the event. The logistics behind running any professional wrestling event is very complex.

I do hope that I have answered your questions and that you don't edit this to change any of my wording. I believe in being straight with everything, and hope that you can give me the same respect, and not omit any of my statements or words. Thank you!
